
Initiation Fee: New members in the Clarklake Beach & Boat Club pay a \$200 initiation fee. For Full Stockholding Members, \$10 of this is allocated for a share of stock for full members.

Payment Options: Annual dues may be paid in full or through electronic funds transfer (EFT). Depending on when a member joins, certain Club dues proration policies may apply.

Cash Payment: If paid in full, the \$200 initiation fee plus the applicable annual dues are payable with the application.

EFT (Electronic Funds Transfer) provides regular automatic monthly deduction from your bank account for annual dues. The initiation fee is paid and EFT begins for monthly membership.

New Member Plan (Available June-August) allows a deposit on the initiation fee and participation in the EFT payment option. The balance of the initiation fee is paid by the end of the year, and normal monthly EFT amounts apply thereafter.

Members selecting Regular EFT or the New Member Plan must stay with electronic funds transfer through May of the next year or pay the equivalent if converting to cash based membership.

If you choose to have EFT deductions from the same account as the check written for the initiation fee or deposit, complete the items marked **1** (and **2** if a joint account). We will process the electronic transfer from the same account.

If you wish to have the payment deducted from a different checking account, please complete items marked 1 (and **2** if a joint account) and return this form with a voided blank check from the account you choose for the monthly deduction.

If you prefer to have your monthly dues deducted from a saving account, please complete all information (including items marked 2 if a joint account) and return with your initiation fee.
