MEMBERSHIP OPTIONS:

1. **FULL MEMBERSHIP:** A recreational membership includes the member and spouse named in the application and dependent children (19 or under or full-time college students) that live in the same household.
2. **SENIOR MEMBERSHIP:** A recreational membership for those 62 years or older includes the member and spouse named in the application and dependent children (19 or under or full-time college students) that live in the same household. **A SENIOR MEMBERSHIP DOES NOT INCLUDE VOTING RIGHTS OR MARINA PRIVILEGES.**

FEES:

INITIATION FEE: New members to the Clarklake Beach & Boat Club pay a **\$200 non-refundable initiation fee**. This fee must accompany this application.

DUES:

Full Membership - \$450

Senior Membership - \$300

PAYMENT OPTIONS:

1. **Payment in Full:** Annual dues are paid in full prior to beginning of season
2. **EFT (electronic funds transfer):** provides regular automatic monthly deduction from your bank account for annual dues. **Complete EFT authorization agreement form** (*members are responsible for the amount in full if canceling payments before December of that year.)

If you choose to have EFT deductions from the same account as the check written for the initiation fee, complete the items marked 1 (and 2 if a joint account). We will process the electronic transfer from the same account.

If you wish to have the payment deducted from a different checking account, please complete items marked 1 (and 2 if a joint account), and return a voided blank check with this application from the account you choose for the monthly deduction.

If you prefer your monthly dues deducted from a saving account, please complete all information (including items marked 2 if a joint account)
